



General Fund Net Revenues

Commentary for the month of November FY 2013

General Fund net revenues during the month of November 2012 totaled \$491 million, reflecting an increase of \$10 million when compared to November 2011.

- Individuals' tax collections were \$140.5 million, an increase of \$0.2 million when compared to November 2011 revenues.
- Excise tax on certain multinational groups (Act 154) totaled \$160.5 million.
- Corporate tax collections for the month of November 2012 were \$22.5 million.
- Sales and Use Tax (SUT) collections for the month of November 2012 totaled \$94.5 million, a 3.5% year-over-year increase. First \$607 million in SUT collections are allocated to COFINA for the payment of outstanding bonds.
- November 2012 non-resident withholdings totaled \$50.2 million, a 40% year-over-year increase.
- November 2012 off-shore shipments of rum collections totaled \$18.7 million.
- General Fund net revenues YTD for fiscal year 2013 totaled \$2.701 billion, a reduction of \$65.6 million when compared to fiscal YTD net revenues.
